## CEO'S NOTE

The Americans with Disabilities Act (ADA) is a landmark bill signed into law by George H.W. Bush on July 26, 1990, which prohibits discrimination based on disability. On this 27th anniversary celebrating the signing of the Americans with Disabilities Act, I would like everyone to take the time to recognize that in addition to the rights individuals with disabilities are given under that law of the land, they also deserve respect and compassion by the law of human rights.

As a Center for Independent Living, The League of Human Dignity promotes the full and equal participation of men, women and children with disabilities in all aspects of life. We advocate for public policy that ensures self-determination, independence, empowerment, and inclusion for people with disabilities in areas such as accessibility, education, healthcare, housing, and voting rights.

Please take the time to learn about this ever growing population and learn some common courtesies for engaging people with disabilities.

1. Personal Questions – Avoid asking personal questions about someone's disability. If you must ask, be sensitive and show respect. Do not probe if the person declines to discuss it.
2. Patience – It may take extra time for a person with a disability to do or say something.
3. Offering Assistance – Be polite and friendly when offering assistance and wait until your offer is accepted. Listen or ask for specific instructions.
4. Meetings & Events – Create an environment that is welcoming and accessible to everyone. Anticipate specific accommodations that a person or group with a disability might need and contact them for information on how to best meet their needs.

These common courtesies will go a long way toward not only making people with disabilities feel valued and an important part of society; but also in changing the regard in which they are held by society as their personalities and abilities—and not just their disabilities—are brought into focus.

## Sign-Up for Social Security Now Easier Than Ever

Social Security benefits should be the icing on the cake after a lifetime of hard work and the folks at the Social Security Administration say they're working hard to ensure that getting those benefits is as quick and painless as possible.

They say they've streamlined the application process — just go online to [www.socialsecurity.gov/applyforbenefits](http://www.socialsecurity.gov/applyforbenefits) to get started. Through the website, you can apply for:



- Retirement benefits
- Spousal benefits
- Medicare
- Disability benefits
- Extra Help with Medicare prescription drug plan costs
- Supplemental Security Income

Social Security officials promise that you don't have to be internet savvy to finish most of the online applications in one sitting with your computer. There also is still the option to apply in person at your Social Security office or by telephone. Call 1-800-772-1213 from 7 a.m. to 7 p.m. weekdays to schedule an appointment.

You should also call to schedule an appointment to apply for certain family benefits, including surviving spouses and children, divorced spouses and dependent children, and parents of beneficiaries.

After an application has been filed, you can check the status of a pending claim through your online "my Social Security" account. If you haven't created your account yet, you can do so by visiting [www.socialsecurity.gov/myaccount](http://www.socialsecurity.gov/myaccount).

You can also use my Social Security to view estimates of how much you would receive in retirement benefits and potential disability benefits and how much your loved ones could receive in family or survivor benefits.

# Weather Service Summer Heat Advisories Explained

We're well into summer and folks in Nebraska and Iowa know that means — heat and humidity, sometimes in dangerous amounts.

One of the best ways to be prepared is to turn to the National Weather Service for its heat-related announcements. As conditions dictate, each Weather Service Forecast Office issues the following heat-related announcements:

**Excessive Heat Warning: Take Action!** Issued within 12 hours of the onset of extremely dangerous heat conditions. Generally, when the maximum heat index temperature is expected to be 105-degrees or higher for at least two days and nighttime temperatures will not drop below 75 degrees.

**Excessive Heat Watch: Be Prepared!** Issued when conditions are favorable for an excessive heat event in the next 24 to 72 hours. A Watch is used when the risk of a heat wave has increased but its occurrence and timing is still uncertain.

**Heat Advisory: Take Action!** Issued within 12 hours of the onset of extremely dangerous heat conditions. Generally, when the maximum heat index temperature is expected to be 100 degrees or higher for at least two days, and nighttime temperatures will not drop below 75 degrees.

**Excessive Heat Outlook:** Issued when the potential exists for an excessive heat event in the next three to seven days. An Outlook provides information to those who need considerable lead-time to prepare for the event.

The Weather Service warns that if you don't take precautions when temperatures are extreme, you may risk seriously illness or death. Criteria do vary across the country, especially in areas not used to extreme heat. Weather Service local offices work with local partners to determine when an alert should be issued.

# Barrier Removal Grants

Barrier Removal Grants are available to qualifying renters or homeowners and their family members who have mobility limitations.

Grants are available to:

- People in Omaha, Council Bluffs, and Lincoln & Lancaster County.
- People with low to moderate income, as defined by the U.S. Department of Housing and Urban Development.
- People who need help removing barriers in their homes.



Examples of eligible modifications include outside ramps and lifts, grab bars, handrails, widened doorways, accessible tubs and showers, and reachable sinks and counters.

# After Hours Transportation for Lincolmites with Disabilities

The League of Human Dignity Extended Hours Service (EHS) Transportation Program offers 70 rides each week, for people with disabilities in Lincoln, who need accessible, affordable transportation when other options are not available.



So, if you have a disability and don't drive — and it's late or it's the weekend or a holiday, and the city buses and HandiVans aren't running, EHS is there for you.

EHS is for people who are eligible for Lincoln's StarTran HandiVan service and who use Lincoln's fixed-route buses or other assisted transportation, or who experience permanent disability and do not have a vehicle of their own and valid driver's license.

A HandiVan or EHS identification is required — eligible residents can get both at the League of Human Dignity, 1701, P Street, in Lincoln. Stop in or call 402-441-7871 for details about eligibility and registration.

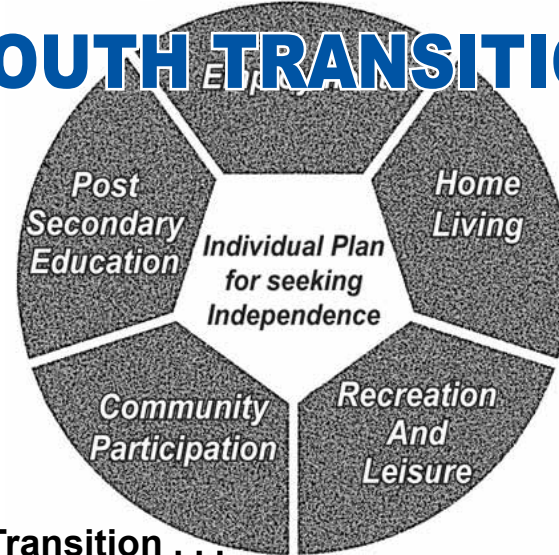
EHS offers rides weekdays from 5 to 11 p.m.; Saturdays from 8 a.m. to 11 p.m.; Sundays from 8 a.m. to 5 p.m.; and on Memorial Day, the Fourth of July, Labor Day, Thanksgiving, Christmas and New Year's Day from 8 a.m. to 5 p.m. Each one-way ride is \$4.

Reservations for rides are accepted Monday through Friday from 9 a.m. to 4:30 p.m. Reservations may be made from one to seven day prior to a requested ride. Same-day requests are subject to space availability.

### Youth Transition . . .

It is about putting the pieces in place that a young adult may need to accomplish their dreams and lifelong happiness.

The Purpose of Youth Transition — to ensure that young adults will gain the skills, knowledge and interagency relationships to establish long-range goals for independence after high school.

The League of Human Dignity's transition component serves students age 14 to 26.



The League assists youth and young adults with disabilities to transition from high school and life with parents to post-secondary education, employment and, for some, independent living.



# Talking Book & Braille Service Offers Free Reading Assistance

People with limited ability to read, hold a book or turn pages still can enjoy their favorite books and magazines, through to the Nebraska Library Commission's free Talking Book and Braille Service.

The program provides free audiobooks and audio magazines and braille through the mail and through digital download to individuals with a visual or physical condition, or a reading disability which limits use of regular print.



The collection consists of books and magazines similar to those found in a public library. The program provides easy-to-use playback equipment on long-term-loan free of charge. Materials in the collection and the playback equipment are mailed to and from the library postage-free.

The service is available to individuals, as well as schools and other facilities, such as nursing homes, hospitals and senior citizen centers.

The program's in-house sound studios also record and produce audiobooks and audio magazines from Nebraska and regional authors as well as material about Nebraska and the Great Plains. The recordings from the Nebraska Collection also are made available for loan to patrons.
