October is an important month on many levels. One important element of October is that this is National Disability Awareness Month (NDEAM) and is a time to celebrate the many varied contributions of America's workers with disabilities.

This year marks the 75th anniversary since the first observance. The 2020 NDEAM theme is "Increasing Access and Opportunity." This year correlates to the 30th anniversary of the Americans with Disabilities Act as well. The ADA is landmark civil rights legislation that works to increase access and opportunity for people with disabilities across society, including in the workplace.

The League of Human Dignity, Inc. is proud to support National Disability Employment Awareness Month (NDEAM). Held each October, NDEAM aims to educate about disability employment issues and celebrate the many and varied contributions of America's workers with disabilities.

The history of National Disability Employment Awareness Month traces back to 1945 when Congress enacted a law declaring the first week in October each year "National Employ the Physically Handicapped Week." In 1962, the word "physically" was removed to acknowledge the employment needs and contributions of individuals with all types of disabilities. In 1988, Congress expanded the week to a month and changed the name to National Disability Employment Awareness Month.

Employers and employees in all industries can learn more about how to participate in Na-

tional Disability Employment Awareness Month and ways they can promote its messages — during October and throughout the year — by visiting www.dol.gov/NDEAM.

October is also a month to remind everyone that the general election is scheduled for Tuesday, Nov. 3, 2020. Every American who is registered to vote will be afforded the opportunity to help choose the individuals who will be representing and leading our cities, towns, states and country. Because this year is the 59th quadrennial presidential election, this election is of paramount importance.

Inclusion an ‘Important Part’ of Economic Recovery

The theme for this year’s National Disability Employment Awareness Month (NDEAM) is “Increasing Access and Opportunity.”

This year marks the 75th annual observance of NDEAM, a celebration administered by the U.S. Department of Labor’s Office of Disability Employment Policy. The observance culminates the Department’s commemoration of the 30th anniversary of the Americans with Disabilities Act.

Each October, NDEAM celebrates America’s workers with disabilities and reminds employers of the importance of inclusive hiring practices.

“Ensuring that America’s workplaces continue

to include and accommodate people with disabilities will be an important part of our economic rebound,” said U.S. Secretary of Labor Eugene Scalia. “Looking ahead, the Department will remain focused on the policies that led to a strong economy and record-low unemployment rates for persons with disabilities prior to the pandemic. A vigorous economic rebound and job growth will, alongside the Americans with Disabilities Act, increase access and opportunity for Americans with disabilities.”

Have Your Say: Head to the Polls

Take Part in General Election, Help Steer Future Policy Decisions

What does the future hold for U.S. policy that impacts people who have disabilities?

Nebraska and Iowa voters can have a say on the first Monday in November. That's the day – Nov. 3 – when voters head to the polls and cast their votes for President and Vice President of the United States, as well as members of the U.S. Senate and House of Representatives.

Presidential Race

Nationally, voters will decide whether Pres. Donald Trump and Vice President Mike Pence will remain in office, or Democratic challengers Joe Biden and Kamala Harris will lead for the next four years.

In Nebraska, Libertarian Party Presidential candidate Jo Jorgensen and her running mate Jeremy Cohen also are on the ballot.

Iowa voters have the choice of five additional party candidates and two non-partisan teams running for president and vice president. They are Alliance Party candidates Rocky De La Fuente and Darcy Richardson; Constitution Party candidates Don Blankenship and William Mohr; Genealogy Know Your Family History Party candidates Ricky Sue King and Dayna Chandler; Green Party candidates Howie Hawkins and Angela Walker; and Libertarian candidates Jorgensen and Cohen. Candidates with no party designation are Brock Pierce and Karla Ballard; and Kanye West and Michelle Tidball.

In addition to the presidential race, voters across the country will elect representatives from all House of Representative districts, including three from Nebraska and four from Iowa; and about one-third of the 100 senate seats, including one each from Nebraska and Iowa.

Nebraska Senate, House Races

Voters in Nebraska will elect one U.S. Senator and three Representatives.

Republican incumbent Ben Sasse of Fremont is running for his second six-year Senate term. He is facing challengers Chris Janicek, a Democrat from Omaha, and Gene Siadek, a Libertarian from Omaha.

In the House races, in District 1, Republican incumbent Jeff Fortenberry of Lincoln, a representative since 2005, faces challengers Kate Bolz, a Democrat from Lincoln, and Dennis B. Grace, a Libertarian from Fremont.

In District 2, Republican incumbent Donald Bacon, from Papillion, a representative since 2017, faces Democrat Kara Eastman of Omaha, and Libertarian Tyler Schaeffer of Omaha.

In District 3, Republican incumbent Adrian Smith of Gering, a representative since 2007, faces Mark Elworth Jr., a Democrat from Omaha, and Dustin C. Hobbs, a Libertarian from Grand

Island.

For a complete list of all state-level candidates, visit the Nebraska Secretary of State website, sos.nebraska.gov. Polling places in Nebraska are open from 8 a.m. to 8 p.m. in the Central Time Zone and 7 a.m. to 7 p.m. in the Mountain Time Zone.

Iowa Senate, House Races

In Iowa, Republican Incumbent Joni Ernst is seeking her second term in the Senate, Challenging her are Democrat Theresa Greenfield of Des Moines, Libertarian Rick Stewart of Cedar Rapids, and Suzanne Herzog of West Des Moines, who is nonpartisan.

In Iowa's District 1, incumbent Abby Finkenauer, a Democrat, faces Ashley Hinson, a Republican.

Are You Registered to Vote on Nov. 3?

To register to vote in the general election in Nebraska, you must be 18 or turn 18 by Nov. 3, a resident of the county where you will vote, and a U.S. citizen. If you have been convicted of a felony you cannot register until two years after the completion of your sentence, including probation or parole. You cannot register if you have been found mentally incompetent by a court.

There are several ways Nebraska residents can register to vote, including online at [NEReg2Vote](#). The online application is always available and is accessible by computer and mobile devices. Register in person through the state Department of Motor Vehicles when applying for or renewing your driver's license. Register through the state Department of Health and Human Services and State Department of Education at the time of application, review or change of address for public programs.

An online voter registration application can be printed for you, to be completed, signed and mailed to your county election office. Addresses for the offices are listed on the form.

The deadline to register to vote in the general election is Oct. 16.

If it's your first time registering to vote in Nebraska by mail, you must also provide a copy of a current valid photo ID, or other proof you live at the address given on your application, including a copy of a utility bill, bank statement, government check, paycheck or other government document, dated within 60 days of the date on your voter registration application.

In Iowa, you can register to vote if you are a U.S. citizen, an Iowa resident and will be at least age 18 on Election Day.

Iowans can pre-register online at the Iowa

Secretary of State website or download, fill out and mail a voter registration form to their county elections official. The deadline to preregister is 10 days before the general election.

Iowans can register and vote on Election Day by going to their correct polling place with proof of identity and current address.

Early (Absentee) Voting

In Nebraska, any registered voter can request an early voting (absentee) ballot.

Contact your county election office in person, by mail or by fax for an early-voting application or print an online early-voting application. Complete the application and mail, fax or email it to your county election office. The deadline to request that a ballot be mailed to you is 6 p.m. Oct. 23. Early ballots must arrive at your county elections official's office by the time the polls close on Election Day.

Any registered voter in Iowa can request an absentee ballot through their county auditor. Absentee voting begins Oct. 5 and ends Nov. 2.

A completed absentee ballot must be received by mail by Nov. 9, postmarked no later than Nov. 2. The deadline to return a completed ballot in person is Nov. 3.

In District 2, Democrat Rita R. Hart and Republican Mariannette Miller-Meeke face off in a race to replace retiring Democrat Dave Loebsack.

In District 3, the southwestern part of the state, incumbent Cindy Axne, a Democrat from West Des Moines, faces challengers David

Young, a Republican from Van Meter, and Bryan Jack Holder, a Libertarian from Council Bluffs.

In District 4, Republican Randy Feenstra faces Democrat J.D. Scholten, in a race to replace Republican Steve King, who lost in the primary.

Loan & Rental Program

Have you ever had a family member suffer a minor injury that required the use of crutches or a wheelchair for a short time? Has a recent illness or accident made it necessary to use a walker, transfer bench or a commode? Do you have equipment that you no longer need?

The League of Human Dignity's **Equipment Loan Program** allows you to rent or borrow many durable medical equipment items for a small fee. We also encourage donations of these items.

We do not loan or rent items that require special or custom fitting and/or supervision by a doctor, such as braces or corsets.

All donated items need to be in good shape. We do not accept donations that need repair.

Items we loan include Tub Seats & Benches, 2-Wheel Walkers, Canes, Crutches, Commodes, Reachers, and Grab Bars.

A one-time fee of \$5 is required — \$25 for Rollator Walkers — and the loan lasts as long as the items are needed. All loans are subject to availability.

Items we rent include Manual Wheelchairs, Transport Wheelchairs, Rolling Shower Chairs, Knee Walkers, and Hoyer Lifts.

Monthly rental and deposits vary by item and rent includes all maintenance and servicing during rental period. All rentals are subject to availability.

Keep Reading with Talking Book & Braille Service

People who have limited ability to read, hold a book or turn pages still can enjoy their favorite books and magazines, through to the Nebraska Library Commission's free Talking Book and Braille Service.



The program provides free audiobooks and audio magazines and braille through the mail and through digital download to individuals with a visual or physical condition, or a reading disability

which limits use of regular print.

The collection consists of books and magazines similar to those found in a public library. The service is part of a nationwide network of cooperating libraries headed by the National Library Service, a division of the Library of Congress.

The program provides easy-to-use playback equipment on long-term-loan free of charge. Materials in the collection and the playback equipment are mailed to and from the library postage-free.

The service is available to individuals, as well as schools and other facilities, such as nursing homes, hospitals and senior citizen centers.

The program's in-house sound studios also record and produce audiobooks and audio magazines from Nebraska and regional authors as well as material about Nebraska and the Great Plains. The recordings from the Nebraska Collection also are made available for loan to patrons.

People with disabilities have the same rights to live independently as anyone else. That's why the League of Human Dignity has been here for nearly 50 years — the services provided by the League's Centers for Independent Living help people to achieve and maintain their independence.

Services include, but are not limited to:

- Individual and systems advocacy
- Information and referral
- Independent living skills training
- Peer counseling and support
- Transition from institutions to the community or from school to the next phase of life
- Training in personal assistant hiring and management
- Barrier removal grants
- Equipment loan and rental

Our CILs serve 43 Nebraska counties and eight counties in Southwest Iowa. We serve all 93 Nebraska counties with Medicaid Waiver services.

Social Security Admin Continues Scam Warnings

The most effective way to defeat scammers is to know how to identify scams.

You should just hang up on any call you're uncertain of and ignore suspicious emails, said Jewell Colbert, Regional Communications Director for the Social Security Administration's Kansas City Region. Scammers are always finding new ways to steal your money and personal information by exploiting your fears.

One common tactic is posing as federal agents or other law enforcement. They may claim your Social Security number is linked to a crime. They may even threaten to arrest you if you do not comply. Just hang up.

As a reminder, continue to remain vigilant of phone calls when someone says there's a problem with your Social Security number or your benefits. If you owe money to Social Security, the agency will mail you a letter explaining your rights, options, and information about appealing.

Remember, Social Security officials will never:

- Threaten you with benefit suspension, arrest, or other legal action unless you pay a fine or fee.
- Promise a benefit increase or other assistance in exchange for payment.
- Require payment by gift card, cash, wire transfer, internet currency, or prepaid debit card.
- Demand secrecy from you in handling a Social Security-related problem.
- Send official letters or reports containing personally identifiable information via email.

If you don't have ongoing business with Social Security, it is unlikely the agency will contact you. So if you get a suspicious call claiming to be from Social Security, hang up and report it to the agency's Office of the Inspector General at oig.ssa.gov.



Barrier Removal Grants

Barrier Removal Grants are available to qualifying renters or homeowners and their family members who have mobility limitations.

Grants are available to:

- People in Omaha, Council Bluffs, and Lincoln & Lancaster County.
- People with low to moderate income, as defined by the U.S. Department of Housing and Urban Development.
- People who need help removing barriers in their homes.

Examples of eligible modifications include outside ramps and lifts, grab bars, handrails, widened doorways, accessible tubs and showers, and reachable sinks and counters.

League staff offer a variety of services to as-
