

## League Employees Mark Anniversaries During 2021

During 2021, eight League of Human Dignity employees in four offices around the state observed work anniversaries, ranging from five to 20 years.

The eight have amassed a cumulative 70 years of service to people with disabilities in Nebraska.

Leading the list is Services Coordinator Meagan Bateman, who works in the League's Omaha office. Meagan reached her 20-year anniversary in July. She joined the staff of the Omaha office on July 20, 2001.

Service Coordinators work with consumers in Nebraska's Medicaid Waiver Program.

## *Social Security to Go Up in January*

Social Security recipients will be getting a raise in 2022.

About 70 million Americans will see their benefits and Supplemental Security Income payments go up starting in January, when a new 5.9 percent cost of living adjustment kicks in.

This will be the largest Social Security cost of living adjustment, COLA, in 30 years.

The Social Security Administration will mail COLA notices in December to retirement, survivors, disability beneficiaries, SSI recipients, and representative payees. Or, recipients can see their notice online, beginning in early December, using the Message Center in their My Social Security account.

January 2022 marks other changes including an increase in the maximum amount of earnings subject to the Social Security payroll tax.

# Medicare Costs Going Up Again in 2022

Medicare premiums will be going up again in 2022.

The Centers for Medicare & Medicaid Services announced to increase in Part A and B premiums, deductibles and coinsurance, and in the Part D income-related monthly adjustment in November.

Officials said, though, that the promised cost of living adjustment in Social Security will more than cover the hike in the Part B premium. Most people with Medicare will see a 5.9 percent increase in their Social Security benefits — the largest COLA in 30 years.

The standard Part B monthly premium will go up from \$148.50 in 2021, to \$170.10 in 2022 — an increase of \$21.60.

The increase reflects rising healthcare costs; in part makes up for limits placed on premiums during the COVID-19 pandemic; and reflects the need to maintain a contingency reserve for potential increases in health care spending and drug costs, including Alzheimer's drugs.

## Part B Deductible

A retiree who currently receives \$1,565 a in Social Security can expect to receive a net increase of \$70.40 a month after the Medicare Part B premium is deducted.

By law, the Medicare Part B monthly premium must equal 25 percent of the estimated total Part B costs for enrollees age 65 and over.

The annual deductible for Medicare Part B is increasing from \$203 in 2021 to \$233 in 2022.


Medicare Part B covers physician services, outpatient hospital services, certain home health services, durable medical equipment, and certain other medical and health services not covered by Part A. Part A covers hospitalization and some nursing home and home health care.

Part A is based on the number of quarters in which a person has paid the Medicare deduction. Only about 1 percent of Medicare recipients pay a Part A premium. The inpatient deductible is going up \$72, from \$1,484 in 2021, to \$1,556 in 2022.

## Open Enrollment

The Biden Administration is taking action to address the rapidly increasing drug costs that threaten the future of Medicare and place a burden on people with Medicare beneficiaries. Pres. Biden has proposed lowering prescription drug costs by letting Medicare negotiate drug prices.

Medicare Open Enrollment began Oct. 15 and ends Dec. 7, 2021. It is a chance for the 63 million-plus who rely on Medicare to compare coverage options like Original Medicare (Parts A and Part B) and Medicare Advantage, and choose health and prescription drug plans for 2022. # It's Flu Season; Please Get Vaccinated

Every year, flu is responsible for millions of illnesses, tens of thousands of hospitalizations, and thousands of deaths.

If you are living with certain chronic medical conditions, you are at an even higher risk of developing serious complications from flu, like pneumonia, bronchitis, and other illnesses that can lead to hospitalization or even death. Even if your condition is well-controlled, flu can make it worse — triggering asthma attacks, increase the risk of heart disease and stroke, and make your blood sugar harder to manage.

And that's why National Influenza Vaccination Week — Dec. 5-11 this year — was established, to shine a light on the importance of vaccinations, especially for people with underlying conditions.

The most commonly reported underlying medical conditions in patients hospitalized for flu include heart disease, diabetes, obesity, and chronic lung disease. A flu shot reduces your risk of getting sick with flu. And when it does not prevent an infection, studies show it can help reduce the severity of illness and prevent complications.

As the U.S. continues to battle the COVID-19 pandemic, it's more important than ever. Flu and COVID-19 together could overwhelm our medical systems. We can all do our part to reduce the spread of flu and protect our loved ones and our community from flu, saving medical resources to care for COVID-19 patients. There's still time to get a flu shot.

"Flu activity is still low right now, which means it's a good time to get vaccinated," says Dr. Dan Jernigan, Influenza Division Director at the Centers for Disease Control and Prevention. "We don't know what this season will bring, but we know that a flu vaccine can reduce the risk from flu. Part of our preparedness strategy this winter is to take flu out of the equation as much as possible. Getting a flu vaccine can help do that so there is one less thing to worry about."

## Medicare Advantage Premiums Going Down

The average premium for Medicare Advantage plans will be lower in 2022, as projected enrollment in the plans continues to rise.

The Centers for Medicare & Medicaid Services (CMS) released the 2022 premiums, deductibles and other key information for Medicare Advantage and Part D prescription drug plans on Sept. 30.

The average premium is \$19 per month, compared to \$21.22 in 2021. The average 2022 premium for Part D coverage will be \$33 per month, compared to \$31.47 in 2021.

Enrollment in Medicare Advantage in 2022 is projected to reach 29.5 million people compared to 26.9 million in 2021. Medicare Advantage plans will continue to offer a wide range of supplemental benefits, including eyewear, hearing aids, both

preventive and comprehensive dental benefits, limited access to meals, over-the-counter items, fitness benefits and worldwide emergency/urgent coverage. The percentage of plans offering special supplemental benefits for chronically ill patients will increase from 19 percent to 25 percent.

To help with their Medicare costs, low-income seniors and adults with disabilities may qualify to receive financial assistance from the Medicare Savings Programs (MSPs). The MSPs are essential to help millions of Americans access high-quality health care at a reduced cost, yet only about half of eligible people are enrolled.

# Handwashing Helps Halt Spread of Germs

December 5-11 is National Handwashing Awareness Week.

Washing your hands is one of the most effective ways to prevent the spread of germs. Studies have shown that handwashing can prevent 1 in 3 diarrhea-related sicknesses and 1 in 5 respiratory infections, such as a cold or the flu.

The Life is Better with Clean Hands Campaign, started by the Centers for Disease Control and Prevention (CDC) encourages adults to make clean hands a healthy habit at home and away.

Follow these five steps every time.

1. Wet your hands with clean, running water (warm or cold), turn off the tap, and apply soap.
2. Lather your hands with the soap. Lather the backs of your hands, between your fingers, and under your nails.
3. Scrub your hands for at least 20 seconds. Need a timer? Hum the "Happy Birthday" song from beginning to end twice.
4. Rinse your hands well under clean, running water.
5. Dry your hands using a clean towel or air dry.

If soap and water aren't available, you can use an alcohol-based hand sanitizer that contains at least 60% alcohol.

# Smart Technology Makes Wheelchairs More Safe

It doesn't take much to make a power wheelchair tip over — there are tens of thousands of accidents each year.

Nashville songwriter Barry Dean, whose daughter Katherine has cerebral palsy and has experienced that fact first-hand, decided to do something about it.

Dean and his brother, an engineer, created LUCI, a power wheelchair add-on with sensors to monitor surroundings, detect potential hazards, alert the user, and even slow or stop the chair.

According to the 2021 LUCI Safety Report, the equipment's curb drop-off protection is 99 percent effective. It claims to be 100 percent effective at slowing a chair and about 95 percent effective in stopping a chair completely before a collision.

The equipment costs \$8,445, including installation and financing is available. It is currently available for Permobil M3, M5, F3 and Quantum Edge power chairs, and will be available to Sunrise QUICKIE users soon.

The LUCI company is headquartered in Nashville, TN, and the equipment is manufactured in Denver, CO.

## BRP Grants

**Barrier Removal Grants** are available to qualifying renters or homeowners and their family members who have mobility limitations.

Grants are available to:

- People in Omaha, Council Bluffs, and Lincoln & Lancaster County.
- People with low to moderate income, as defined by the U.S. Department of Housing and Urban Development.
- People who need help removing barriers in their homes.

Examples of eligible modifications include outside ramps and lifts, grab bars, handrails, widened doorways, accessible tubs and showers, and reachable sinks and counters.

# Keep Sidewalks Clear, Passable This Winter

Winter is on the way and with it chances for snow and ice, making it harder for everyone to get around.

If you find it difficult walking through snow or on ice, imagine the difficulty for someone using a wheelchair, walker or other mobility device. The League reminds everyone to keep that in mind this winter and please keep your sidewalks and curb cuts clear and passable.



Sidewalks are a lifeline for people with disabilities and seniors. When snow or ice makes them impassable, that may prevent people from getting to work, to the store, or to the doctor. If someone using a wheelchair is forced into the street because of a blocked sidewalk, that puts them at the mercy of

traffic and could become a matter of life or death.

This is more than an issue of good citizenship and neighborliness – it's also the law. Lincoln, Omaha, Council Bluffs, Norfolk, and most other cities and communities have ordinances that require snow removal on public sidewalks within a specified period of time. Fines may result for not abiding by the ordinances. Contact your local city government for more information on snow removal ordinances.

# League Loan & Rental Program

Have you or a family member ever suffered a minor injury that required the use of crutches or a wheelchair for a short time? Has a recent illness or accident made it necessary to use a walker, transfer bench or a commode? Do you have equipment that you no longer need?

Through the League of Human Dignity's **Equipment Loan Program**, you can rent or borrow many durable medical equipment items for a small fee. We also encourage donations of these items.

We do not loan or rent items that require special or custom fitting and/or supervision by a doctor, such as braces or corsets.

All donated items need to be in good shape. We do not accept donations that need repair.

**Items we loan** include Tub Seats & Benches, 2-Wheel Walkers, Canes, Crutches, Commodes, Reachers, and Grab Bars.

A one-time fee of \$5 is required — \$25 for Rollator Walkers — and the loan lasts as long as the items are needed. All loans are subject to availability.

**Items we rent** include Manual Wheelchairs, Transport Wheelchairs, Rolling Shower Chairs, Knee Walkers, and Hoyer Lifts.

Monthly rental and deposits vary by item and rent includes all maintenance and servicing during rental period. All rentals are subject to availability.

The annual four-day conference is the largest conference on the Americans with Disabilities Act and the


