

# Proposal Could Make Airline Bathrooms Accessible

The U.S. Department of Transportation has announced that it plans to implement rules requiring accessible bathrooms on single-aisle airliners.

The Notice of Proposed Rulemaking was announced March 18.

“Far too often, travelers with disabilities don’t have the opportunity to fly to their destinations because they can’t access the lavatories on most airplanes,” said U.S. Transportation Secretary Pete Buttigieg. “This rule would make airplane lavatories more accessible for passengers with disabilities, and bring us one step closer to the day when air travel is possible for everyone.”

Single-aisle aircraft now operate the vast majority of domestic flights, including a large share of long, cross-country flights. The proposed rule would require airlines to make at least one lavatory on

new single-aisle aircraft with 125 or more passenger seats large enough to permit a passenger with a disability — with the help of an assistant, if necessary — to approach, enter, and maneuver within the aircraft lavatory, use all facilities in that lavatory, and leave, using the aircraft’s onboard wheelchair.

The down side is that it could be decades before any actual change. The proposed rule would apply to new aircraft ordered 18 years after the effective date of the final rule or delivered 20 years after the effective date of the final rule.

That timetable is the result of a 2016 negotiation that produced a consensus among a cross-section of stakeholders. The department is seeking comment, though, on whether accessibility improvements could be implemented more quickly.

# Social Security Offices to Begin Reopening

The Social Security Administration has announced that it is preparing to open its offices to more in-person visits.

Local offices will begin adding more in-person appointments and offer in-person service for people without an appointment beginning in early April, according to a Social Security release.

In-person appointments have generally been limited to emergencies since March of 2020. At that time offices closed to the public and switched to primarily remote services due to the COVID-19 pandemic.

“During the pandemic, millions of people used our secure and convenient online services and received help by phone and in our offices by ap-

pointment,” said Social Security Associate Commissioner Jeffrey Buckner.

“For people who can access our services online or by phone, we ask that they continue to do business with us online or by phone and schedule an appointment, when possible, which will better allow us to timely serve people who cannot use those options.”

Opening up the offices to the public again is welcome news and couldn't come soon enough for many Social Security recipients. The switch to primarily remote services has apparently not been entirely problem free. The move reportedly has created a systematic backlog as well as administrative issues that will need to be fixed, according to news reports.

# Fair Housing Act Turns 54 on April 11

## Annual Celebration of Effort to End Housing Discrimination

Each April marks the celebration of the anniversary of the Fair Housing Act in this country. The observance highlights the country's efforts to end housing discrimination and raises awareness of fair housing rights.

This April marks the 54th anniversary of the Fair Housing Act — officially designated as Title VIII of the Civil Rights Act of 1968 — and a recommitment to the goal of eliminating housing discrimination in every community.

After a long, difficult legislative process, Pres. Lyndon Johnson signed the act into law on April 11, 1968, following the assassination of the Rev. Martin Luther King Jr. The law was a follow-up to the Civil Rights Act of 1964. Its enactment was such an achievement that its first anniversary in 1969, and each year since, has been designated as a time for celebration.



Fair housing means that everyone has the same right to buy or rent safe, decent housing without discrimination on the basis of race, color, religion, national origin, sex, familial status, and disability. While progress has been slow and much still remains to be done, the law at least keeps alive the dream of communities that are open and welcoming, free from discrimination and hostility

The official ceremony celebrating this year's Fair Housing Month is set for 2 p.m. on April 5.

The U.S. Department of Housing and Urban Development (HUD) is celebrating the 54th anniversary of the Act with events highlighting the impact and significance of this landmark civil rights law.

The theme of this year's Fair Housing Month is "Fair Housing: More Than Just Words." It is a call to take action to end housing discrimination and to raise public awareness for fair housing rights and responsibilities, according to the announcement of the event on the HUD website.

The ceremony is part of the virtual Fair Housing Month, via webcast, from 2 to 3:05

p.m. Eastern Time — 1 to 2:05 p.m. Central. The event is hosted by the Office of Fair Housing and Equal Opportunity (FHEO).

## May is Mental Health Awareness Month

Each year millions of Americans face the reality of living with a mental illness.

In fact, nearly 450 million people worldwide are living with mental illness, says the Anxiety & Depression Association of America. And nearly two-thirds never seek treatment.

To raise awareness of mental illness and fight the stigma still attached to mental health disorders, each year advocates in the United States, including the National Alliance of Mental Illness (NAMI), observe Mental Health Awareness Month during May.

"Each year we fight stigma, provide support, educate the public and advocate for policies that support people with mental illness and their families, said a NAMI release. "Together, we can realize our shared vision of a nation where anyone affected by mental illness can get the appropriate support and quality of care to live healthy, fulfilling lives."

For 2022's Mental Health Awareness Month, the theme is "Together for Mental Health."

In Pres. Joe Biden 2021 Mental Health Awareness Month proclamation, it was recognized that the COVID-19 pandemic and resulting economic crisis has impacted the mental health of millions of Americans and increased the need for mental health services.

But even before COVID-19, Biden said, mental health conditions in the country were on the rise. In 2019, nearly 52 million adults experienced some form of mental illness. Data from the Centers for Disease Control and Prevention indicates that one in four adults reported experiencing symptoms of an anxiety or depressive disorder in February 2021.

**Barrier Removal Grants** are available to qualifying renters or homeowners and their family members who have mobility limitations.

Grants are available to:

- People in Omaha, Council Bluffs, and Lincoln & Lancaster County.
- People with low to moderate income, as defined by the U.S. Department of Housing and Urban Development.
- People who need help removing barriers in their homes.

Examples of eligible modifications include outside ramps and lifts, grab bars, handrails, widened doorways, accessible tubs and showers, and reachable sinks and counters.

# League Loan & Rental Program

Have you or a family member ever suffered a minor injury that required the use of crutches or a wheelchair for a short time? Has a recent illness or accident made it necessary to use a walker, transfer bench or a commode? Do you have equipment that you no longer need?

Through the League of Human Dignity's **Equipment Loan Program**, you can rent or borrow many durable medical equipment items for a small fee.



We also encourage donations of these items.

We do not loan or rent items that require special or custom fitting and/or supervision by a doctor, such as braces or corsets.

All donated items need to be in good shape. We do not

accept donations that need repair.

**Items we loan** include Tub Seats & Benches, 2-Wheel Walkers, Canes, Crutches, Commodes, Reachers, and Grab Bars.

A one-time fee of \$5 is required — \$25 for Rollator Walkers — and the loan lasts as long as the items are needed. All loans are subject to availability.

**Items we rent** include Manual Wheelchairs, Transport Wheelchairs, Rolling Shower Chairs, Knee Walkers, and Hoyer Lifts.

Monthly rental and deposits vary by item and rent includes all maintenance and servicing during rental period. All rentals are subject to availability.

# Fed Report: ACA Stronger Than Ever

Health care coverage is up for millions of Americans and prices are down, according to a new federal report.

The “State of the ACA” report, published by the Centers for Medicare & Medicaid Services (CMS), was released on March 23, the 12th anniversary of the Affordable Care Act. The report shows that the Affordable Care Act, sometimes known as Obamacare, is the strongest it has ever been, due to Pres. Biden’s investments in it through the American Rescue Plan.

Nationwide, 2.8 million more consumers are receiving tax credits in 2022 compared to 2021. These tax credits help families keep more money in their pockets for essentials as the nation recovers from the COVID-19 pandemic.

“President Biden promised to build on the success of the Affordable Care Act, and just one year into his Administration, we have already broken records with all-time high enrollment numbers and all-time low prices,” said HHS Secretary Xavier Becerra. “We will continue working to deliver on that promise until we make health care a right for all.”

During the first year of the Biden-Harris Ad-

ministration, nearly 6 million new consumers signed up for coverage through the Marketplaces nationwide during the 2021 Special Enrollment Period and this year’s Open Enrollment Period. Marketplace plans were more affordable, contributing to a record-breaking 14.5 million consumers nationwide signing up for health care coverage – a 21 percent increase from last year.

The uninsured rate for the U.S. fell to 8.9 percent for the third quarter of 2021 (July – September), down from 10.3 percent for the last quarter of 2020.

The Biden-Harris Administration has said it is making it a priority to continue to strengthen the ACA.

The Biden-Harris Administration also has announced a new enrollment opportunity for low-income consumers. This new special enrollment period will make it easier for low-income people to enroll in Marketplace coverage throughout the year.

HHS celebrated the ACA’s 12th anniversary, March 21 through 25. The celebration highlighted the impact of the law and the Biden-Harris Administration’s commitment to building on its success. The theme of the celebration was “ACA: 12 Years of Advancing Health Equity for All Americans.”


